SC rebukes female lawyer over social media post against rape survivor

'Expressing surprise that a woman can write such "derogatory" words about another woman, the Supreme Court on Wednesday rebuked a female advocate over her social media post against a complainant in a case of sexual assault against a Congress MLA from Kerala.

Issuing a stinging reprimand to the woman lawyer, the Supreme Court said her Facebook post was "most derogatory", especially as it was against a woman who was a complainant in a rape case against Congress MLA Rahul Mamkoottathil. A bench of Chief Justice of India Surya Kant and Justice Joymalya Bagchi said it is shocking that a member of the legal profession would use such offensive language against another woman.

"Are you expected to write this type of language? You are an advocate," CJJ Surya Kant told the woman advocate, who was present during the court proceedings with her lawyer as per a report by Live Law.

The woman lawyer, however, said her post was based on information provided by the complainant's husband. "The husband approached me, and he is the

one who informed me, and I posted according to that," she was quoted, to which the CJJ Kant replied: "Do we expect a practising woman advocate to write all these things?"

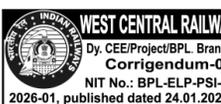
When she argued that the content of her post was not defamatory and did not disclose the complainant's identity, Justice Joymalya Bagchi said it was "most derogatory of a woman" while the CJJ Kant said he was surprised that a "woman can write like this against another woman".

"You have not spared a single word in your dictionary. And still you are not regretting! Should we read out in public what you have written?" he was quoted.

The woman advocate approached the SC seeking protection from arrest by the Kerala police, as she was apprehensive after she published the post. During the hearing, the bench scrutinised the tone and content of the post and remained unconvinced by her justification for writing the post.

Missing woman traced

The police in Jammu and Kashmir's Poonch district said on Wednesday that they have traced a missing woman and reunited her with her family.

Dead man 'trained' to drive e-rickshaw in Bulandshahr, RTO issued certificate

A major case of alleged fraud has surfaced in Bulandshahr where a recognised driving training school issued an e rickshaw training certificate in the name of a person who had died months earlier. The incident has raised serious questions over the functioning of the driving school and the monitoring mechanism of the transport department.

According to officials, Raja Motor Driving Training School in the Syana area, which is recognised by the Deputy Transport Commissioner of the Meerut division, issued a 10 day e rickshaw training certificate in the name of Sukhveer, a resident of Shekhupur Raura. The certificate was issued on August 10, 2025 and mentioned that Sukhveer had undergone training from August 1 to August 10, 2025. The certificate, issued by Imran, also certified that the trainee was physically fit and capable of driving.

However, records show that Sukhveer had died in a road accident on March 1, 2025. His death certificate was issued by the district hospital on April 21, 2025. The revelation has sparked outrage, with questions being raised over how training was shown to have been given to a person who was no longer alive and on what basis the certificate was issued.

The role of the RTO training section in Meerut has also come under scrutiny, as the certificate carried official countersignature. Officials are examining the documents submitted for verification and approval.

Kanpur Lamborghini case takes sharp u-turn, courtroom drama plays out like Jolly LLB

The high profile Lamborghini hit and run case in Kanpur took a sharp U turn on Wednesday, throwing the courtroom into a scene of sudden drama. A man claiming to be the driver surrendered before the court, the injured complainant announced a compromise, and the defence sought release of the seized supercar. The court, however, refused to accept the new version and stuck to the police case, rejecting the plea and keeping the Lamborghini in police custody.

Shivam Mishra, son of a prominent businessman of Kanpur and owner's son of the Lamborghini, was initially identified by the police as the person driving the car when it ran over six people on VIP Road on Sunday. He was named in the FIR after the Police Commissioner said CCTV footage, eyewitness accounts and electronic evidence pointed to him being behind the wheel at the time of the crash.

The dramatic twist unfolded when Mohan appeared before the court with his lawyer and claimed that he, not Shivam Mishra, was driving the car at the time of the accident.
